



## Database of FS legislation and other measures (UK and EU) for a Brexit 'no-deal' scenario

---

### **Last update: 4 February 2019**

This document is a RegZone database of 'no deal' legislation (and other measures) in the financial services sector. It covers EU measures and those in the UK (but not in other Member States). It covers transitional measures and the extensive UK legislation (primary, secondary and at regulator level) to onshore EU regulation and adapt the regulatory regime for exit. Many measures are being impacted or driven to a greater or lesser extent by Brexit and by a 'no deal' factor but many of these fall outside the scope of this database.

Each identified measure is tracked and gives its current status from draft/proposal through to adoption (as at the date of the last update below). Links are provided to the legislation, to explanatory material from official sources and to RegZone analysis on each topic.

The first part deals with the EU and the second with the UK. In the first part, section 1 lists draft RTS and certain other publications relating to a 'no deal' scenario. Section 2 lists the EU transitional measures – 2 temporary equivalence decisions. Section 3 lists some key Brexit impacted/related legislation. Section 4 lists some earlier opinions and communications on Brexit.

In the second part, section 1 lists UK primary legislation, section 2 lists the temporary transitional regimes and the related legislation and section 3 lists the statutory instruments making modifications following onshoring of the EU acquis (NtA), section 4 lists publications from the UK regulators and the annexes contains the full list of draft instruments published by those regulators.
