

# Foreign Ownership in the UAE: The Positive List



In 2018 the UAE passed the Foreign Direct Investment Law (the 'FDI Law'), which was intended to pave the way to relaxing foreign ownership restrictions on companies registered 'onshore' in the UAE. This was a major shift in policy, where in the past foreign investors were restricted to holding only 49% of shares in onshore companies (click here for more details). The FDI Law anticipated that the UAE Cabinet of Ministers would announce a list of commercial activities that would be eligible for up to 100% foreign ownership (referred to as the 'Positive List'). The FDI Law also set out a list of activities for which up to 100% foreign ownership would not be permitted (the 'Negative List').

On 2 July 2019, the UAE Cabinet of Ministers has announced that the Positive List will initially comprise 122 commercial activities across 13 sectors of the economy, which will be eligible for up to 100% foreign investment. While it is anticipated that the list may be updated in due course, as per Cabinet announcement, those 122 activities, together with the corresponding conditions and minimum share capital requirements, is set out below.

Foreign investors should continue to monitor developments closely for further clarifications regarding the Positive list (and any potential changes to the Negative list) and the corresponding foreign ownership thresholds, and for additional activities which are expected to be added in future.
